## Mulroney's formula for inflation

Dear Prime Minister:

Today's column is being devoted to recording some of the public comment that I have heard about your new budget. My ears may have picked up some fine nuances missed by the daily polls on which you seem to rely so much.

ers have looked at your policies and found them a recipe for economic decline. History will record that you presided over the final transformation of our dollar from a hard currency into Third World wampum. When, I wonder, will you have to impose exchange controls?

Over recent years, all major currencies have risen against the U.S. dollar except the Canadian dollar — and the South Korean won. Good company we're keeping these days. Just as bad, we can now watch Ottawa-created inflation begin to steadily increase. In your last budget you de-indexed taxes, meaning that as inflation pushed people's incomes up, they would have to pay even higher taxes.

Very tricky and befitting a Latin American government. So now Ottawa will cause inflation to rise and thus take in more tax money to be spent on bigger limos, faster jetliners and richer meals. All that you have done is peachy for welfare mothers, government workers, tax accountants and those countless groups noisily sucking at the public teat.

But what, sir, about the wage earners and entrepreneurs who pay the bills for this gaudy socialist Nirvana? You are bleeding them dry. In the process, you are turning once proud and secure Canada into an economic cripple and military eunuch. What diminishes us the most, is that you had the power to give Canada bitter medicine and cure its economic sickness. Instead of action and resolve, all we saw was timidity and deception.
